Standing Meeting will be the 2nd Thursday of the month from 9:00 to 10:30.

- Introduction of members, and welcome to Wendy Pennington.
- Update on the data dashboard software and roll-out plans
 - o Briefing on the iDashboards.
 - o Information will be county specific when open as a dashboard to SOC counties.
 - o There will be limited number of login, and some counties may need to share access.
 - o Discussed the need for a descriptive menu to make user/reader friendly.
 - o First phase of data is about HFW, and it is detailed from Contact notes.

- Started with contact notes in January 2015, and there has been about 40,000 contact notes
- It was suggested to have some additional training meetings, including some Staff of PA SOC.
- o Suggested doing this at the live December meeting at the YFTI Advisory Board.
- Review of the final data report from the first SOC grant that just ended on September 30th (attached) this includes both 12 month and 24 month outcomes on HFW/SOC
 - 51 families made it through 12 months and a smaller portion made it through the 24 months.
 - o The report was reviewed in brief.
 - Jill has been working with SAMHSA Social Marketing to see what others are doing as well.
 - o With the data, is the goal to get more counties involved in HFW, or is it something else?
 - Is showing detail on the fidelity as important as the outcomes and the demographics.
 Or is the fidelity more a means of detailing this for counties that may be interested.
 - Overall, we are over the national mean, and maybe that is a better overall message.
 - Wendy L. mentioned that this information can tie in to what is being studied as the state and MCO level.
 - Suggested if there was a way to see if there was a reduction from the 6.6 services at the beginning of the process, to the end outcomes study as this can show some cost savings and outcomes for the county and MCO.
 - The methods to get information out can be paper, website, and social media, and needs to detail the need, and the outcome.
 - It was suggested that we consider the use of QR Codes.
- Brainstorm ideas for how to get our data out in the world
 - Provide our Social Marketer with some ideas for which data to share and in what formats – Jill Santiago will be joining our call and is looking forward to hearing any ideas you have!
 - How can we get this data out to the masses?
 - Jill would like to try to meet with people and find out what is helpful to them – have them test out ideas in their home counties to see how people react.
 - This includes doing different brochures, information on the website.
 - Update on upcoming conference presentations/proposals
 - We are presenting a poster about SOC and HFW at the American Academy of Child and Adolescent Psychiatry (AACAP) conference at the end of the month!
 - Several people will be presenting in New York regarding the work being done and how it can relate to work done by Psychiatrists.
 - Monica will attach the PDF of the poster to the minutes.
 - Tampa Research and Policy conference proposals are due on October 28th and we will be submitting three proposals:
 - HFW outcomes data poster (very similar to the AACAP poster)
 - Healthy Transitions presenting with Utah and Kentucky about how to use data dashboards

- YFTI HFW and peer support (partnering with Child and Family Focus)
- YFTI has presented here for several years.
- An FYI our YFTI Evaluation team was contracted by Allegheny Family Network to conduct a Needs Assessment to understand the education, support, and social needs of families raising children with mental health challenges. We conducted focus groups, key informant interviews, and an online survey. Check out the final report here:

- Gordon brought up a point.
 - Concerns that the most challenging and appropriate youth are receiving the HFW and being affected by SOC.
 - The numbers of referrals coming from Juvenile Probation, the Courts, School and Children and Youth.
 - Dr. Hodas has been consulting with the Children's Bureau for complex cases, and youth that are looking at out of state RTF. Only one youth was HFW utilized.
 - If these youth had HFW earlier, maybe other outcomes could have occurred.
 - This needs to be advertised better
 - Is there a lack of buy in from the system partners, and should they be really identifying the cases that are most appropriate.
 - Green County has been meeting monthly with County partners, to show the data on the outcomes, this resulted in a better partnership with CYF and even using Needs Based Budget funds to support HFW - a great success!
