Pennsylvania established the "PA System of Care Partnership" to meet the needs of youth ages 8-18 with complex mental health challenges and multi-system involvement, and their families. It helps counties and child-serving systems work together in equal partnership with youth and families to bring about positive outcomes and system change.

System of Care is:

A network of effective, community-based services and supports for children and youth with or at-risk for mental health or other challenges and their families...

...is organized into coordinated networks



...addresses cultural and linguistic needs



...builds meaningful partnerships with families and youth;



...in order to help families function better at home, in school, in the community, and throughout life.



CMHS National Evaluation - Longitudinal Outcomes and Satisfaction Study Data Profile Report - 122 youth and families from 13 System of Care counties using High Fidelity Wraparound were enrolled in the study. Some counties expanded services from birth to 21 years old. Outcomes were collected at 6, 12, 18, and 24 months post intake. Data collection for the program is still ongoing; thus, results presented in this report do not represent final results and should not be interpreted as such.

How are PA counties implementing System of Care Standards?

The PA County Assessment is a survey conducted every April to understand how counties are implementing System of Care.



In 2016, we received 447 completed surveys from partners in 50 PA Counties!

Counties reported an average of a Level 8 (out of 10) Implementation score which means that System of Care values and principles are being spread far and wide across PA!



County Leadership Team



188 surveys were received from County Leadership Team (CLT) members across PA, including 42 youth and family partners.

The overall score for this standard was a 9 (out of 10) for Implementation.

Family Driven



75% of all respondents (and 69% of all family partners) reported that there is a family organization or group in their county.

The overall score for this standard was an 8 (out of 10) for Implementation.

Natural and Community Supports



63% of respondents reported that their county promotes connections with natural supports and community resources.

The overall score for this standard was a 7 (out of 10) for Implementation.

Youth and Family Services and Supports Planning Process



78% reported that their county has a planning process model that can be utilized by any youth or family.

The overall score for this standard was an 8 (out of 10) for Implementation.

Youth Driven



55% of all respondents (and 50% of youth partners) reported that there are opportunities for youth voice in each child-serving system.

The overall score for this standard was a 7 (out of 10) for Implementation.

Integration of Child-Serving Systems



64% of respondents reported that the mission, vision, and outcomes of each child-serving system are shared with all partners.

The overall score for this standard was a 7 (out of 10) for Implementation.

Cultural and Linguistic Competence



50% of respondents reported that the county has culturally relevant training available for youth, family, system, and community partners.

The overall score for this standard was a 7 (out of 10) for Implementation.

Evaluation and Continuous Quality Improvement



74% reported that the County Leadership Team regularly reviews data and uses it to make decisions.

The overall score for this standard was an 8 (out of 10) for Implementation.

The PA County Assessment was developed based on work by Beth A. Stroul, M.Ed.; Lan Le, M.P.A.; Bruno Anthony, Ph. D. and adapted for PA. This assessment is designed to explore system of care implementation at the county level and provides a "snapshot" of implementation of the PA SOC standards at a point in time. Results from the assessment provide guidance for improving services and infrastructure in counties and for providing technical assistance to support their efforts to improve systems of care. Annual use of the tool can help a county to determine strengths, progress, and identify challenging areas while implementing the system of care approach. The survey is available both online and on paper and in both English and Spanish. Only surveys that had more than 50% of the questions answered were included in this report. Only scores rated at a 3 "often" (out of 4) or above were included in the percentages in the report above.
